Appendix i: Constitutional Amendments

Libertarian Party of Kentucky Rules Report for 2016

Prepared by Cyrus Eckenberg, Secretary.

The Rules Committee was not convened during the 2015-2016 year. However, pursuant to the duties of the Secretary of the Libertarian Party of Kentucky, the Secretary has prepared this report of proposals to amend the Constitution of the party. These proposals were given to the secretary by members of the LPKY in good standing. They are presented below with only minor changes for the sake of consistent formatting.

Amendment Proposal: Convention Planning

ARTICLE VI: PARTY ORGANIZATION

Section 8. Other Committees

A. Standing Committees

v. Convention Committee

- a. The State Chair shall be the Convention Committee Chair, who shall appoint all Convention Committee members, limited to voting members of the party.
- b. The Convention Committee shall choose the criteria for Annual Convention venues and send the criteria, along with instructions on how and by when to submit an Annual Convention bid, to all District Party Chairs no later than July 1st of each year. Convention venue criteria may change from year to year.
- c. The Convention Committee shall submit a convention venue report to the Executive Committee by December 1st. The report shall include a ranked list of venue recommendations, their estimated costs, and any other relevant information. The report must include all venues submitted as bids from District Chairs.
- d. The Convention Committee shall assist in the planning and organization of any events to be held at the Annual Convention as directed by the Chair.

e. The Convention Committee shall meet no less than once per month between September 1st and the Annual Convention.

Amendment Proposal: Fundraising Committee

ARTICLE VI: PARTY ORGANIZATION

Section 1. Party Structure

- D. An Executive Committee consists of the following positions
 - d. Executive Committee Treasurer, who shall be responsible for
 - 4. Supervising and coordinating fundraising efforts of the Party, and act as coordinator for fundraising events, both with the Party from which it was chartered and all affiliate Parties; and

Section 8. Other Committees

- A. Standing Committees
 - ii. Finance Committee
 - e. The Finance Committee is responsible for dues collection, fund raising and accounting for Party funds.

vi. Fundraising Committee

- a. The Chair of the Fundraising Committee shall be appointed by the Executive Committee from among the members of the Executive Committee of the Party no later than 60 days after the annual convention.
- b. <u>The Fundraising Committee is responsible for organising and supervising the fundraising activities of the party.</u>

Amendment Proposal: End dual office holders in 2017

ARTICLE VI: PARTY ORGANIZATION

Section 2. Qualifications to Serve

E. No person may serve on more than two Executive Committees within the Party, except as the representative from an affiliate Party on the Executive Committee of the chartering Party, as defined in this document. Starting at the close of the State Party Annual Convention held in 2018, no person may serve on more than one Executive Committees within the Party, except as the representative from an affiliate Party on the Executive Committee of the chartering Party, as defined in this document.

Plank #1 - State Sponsored Murder

Today: Governments should not kill people. Democide or 'death by government' is state sponsored murder and was the leading cause of death in the 20th century; it should not be in the 21st century. In the circumstance that the state is complicit or enables the termination of life of civilians, those state sanctioned actions shall be condemned as democide and government actors held judicially accountable.

Tomorrow: We envision a society free from the terrorism of state sponsored murder. The Constitution reserves the power to determine the definitions of murder, manslaughter and justifiable homicide to the states; therefore, any means by which

democide is employed should be immediately refunded on the federal level & delegated to the states for independent legislation.

Plank #2 - Taxation Without Representation

Today: People work in one municipality, and live and vote in another. Yet they are taxed by the municipality in which they work, and have no say in how it is governed nor how it taxes its residents. Special Taxing districts are ruled by unelected boards, generally appointed by the Judge/executive or Mayor or a combination of those or other unelected members. Unelected persons have no accountability to the public and should not have authority to levy taxes.

Tomorrow: "Taxation without representation" was one of the prime issues that the American Revolution was fought over. Why would we let it continue today? We absolutely cannot support any municipality taxing anyone who cannot vote for or against that taxing body. All special district taxes should be voted by elected representatives or by the people at large who will be paying the taxes.

Plank #3: - Farm to Table Agriculture

Today, anyone can sell vegetables, fruits, nuts and herbs *fructus naturales* from their backyard or commercial gardens without government interference. On the other hand, direct sales of meat from farmers to consumers is unconscionably cost prohibitive. Currently all animals slaughtered for sale for human consumption in Kentucky are subject to USDA Inspection. For small producers this is a costly impediment which requires taking the live animal to a slaughterhouse, often a hundred miles or more away. Processing of the animal can then take 2-3 weeks and the farmer must then make the round trip again. Farmers can sell whole live animals then process the animal as a favor to the customer, but the customer must own the animal and the farmer cannot charge for the processing. Consumers often do not want to buy an entire animal, particularly in the case of pigs or cattle because of the upfront costs and the amount of meat and the storage required. This produces a burden both for the producer and the consumer.

Tomorrow, meat should be direct to consumer, not for retail or commercial use, and the consumer should be informed. This will allow consumers to buy from a direct source whom they are confident in, and allow the producers to sell their produce with less overhead.

Plank #4 - Ballot Access

Today: The Kentucky Bill of Rights, Section 6 states: "All elections shall be free and equal." Kentucky's primaries are publically funded but have become biased regarding non-establishment candidates &/or minor parties.

Tomorrow: We envision a more egalitarian ballot access system, employing representative democracy to adhere to the Constitution of the Commonwealth of Kentucky. These processes should be wholly self-funded by their respective parties.

Plank #5 - Religious Law in Courts and the Legislature

Today, many laws on the books are archaic and based solely on the religious views of the lawmakers.

Tomorrow, laws should be impartial to religion, as they are with race, gender and social status; therefore having a law based solely on a particular religion would be discriminatory to those of other religions, or of no religion. Forcing people to superficially follow the laws of a religion does nothing to further one's faith in any meaningful sense. Courts also should not base rulings on religious law, whether it be Levitical law, Shari ah Law, or any other religious code of conduct.

Plank #6 - Deprivation of Life, Liberty or Property without Due Process

Today: Government entities, from taxing bodies, legislatures and law enforcement, regularly confiscate property and money from their citizens without due process, and by force, without even charging, much less convicting, a person of a crime. The use of civil asset forfeiture, escheat, eminent domain, as well as price and wage fixing to enforce laws circumvents constitutional protections and should be ended.

Tomorrow: The 5th Amendment to the United States Constitution states: "No person shall... be deprived of life, liberty, or property, without due process of law." As respect for property rights is fundamental to maintaining a free and prosperous society, it follows that the freedom to contract to obtain, retain, profit from, manage, or dispose of one's property must also be upheld. Libertarians would free property owners from government restrictions on their rights to control and enjoy their property, as long as their choices do not harm or infringe on the rights of others. For voluntary dealings among private

entities, parties should be free to choose with whom they trade and set whatever trade terms are mutually agreeable.
